“Sino-Canadian Business Relations & the Role of Hong Kong”

This year marks the 37th anniversary of the establishment of diplomatic ties between China and Canada. Over the past three-odd decades, bilateral trade and investments between the two countries have steadily grown. With growth in trade and investments between these two nations accelerating in recent years, China is now Canada's second largest trading partner and Canada currently ranks 10th on China's list of its top trade partners. The potential for growth in trade and investment between Canada and China has never been greater. However, there are challenges to be met before the full potential of the bilateral economic relationship can be realized.
